





Alternative Media Production Services Terms and Conditions

- 1. Alternative Media Services will only be provided to students who have a verified disability and whose disability related functional limitations prevent them from reading regular print.
- 2. Student must be enrolled in the course and provide proof of purchase of required course textbooks before receiving the alternative media equivalents.
- 3. Student must check and purchase required textbooks already available in alternative media format (Amazon.com, Bookshare.org, RFBD) **PRIOR TO** submitting an alternative media request.
- 4. Student must contact the course faculty member and obtain required course textbook information using this UCM DS Alternative Media Request form.
- 5. Student must obtain a class syllabus for all courses that require alternative media and attach the syllabus to this form.
- 6. If the student is a client of the Department of Rehabilitation (DR) and requires reader services, the student must complete the DR reader form prior to initiation of reader services. The student or the reader is responsible for submitting reader forms to DR for payment.
- 7. Material provided to the UCM DS for the purpose of conversion to alternative format may be disassembled and returned to the student in its altered condition. UCM DS will not be held responsible for any damage to the materials that occur as a result of conversion to alternative format.
- 8. The student is responsible for informing UCM DS whenever changes occur that affect the student's need for alternate media services.
- 9. All eTexts and tapes will be used solely for the eligible student's own educational purposes and will not be copied or duplicated for use by others. All eText materials (alternative formatted textbooks) or other delivery media, such as CD/DVD/tape, must be returned to DS by the last day of the academic semester.
